## PROPOSED AMENDMENTS TO HONOLULU CITY CHARTER, CHAPTER 16, REGARDING HONOLULU POLICE COMMISSION

Dear Chair Souki and Charter Commission Members:

The purpose of these proposed amendments is to improve the functioning of the Honolulu Police Department (HPD) and help restore the public's trust in the Department. We are fortunate to have many fine police officers and administrators who, not without significant personal sacrifice, have dedicated themselves to keeping Oahu safe. However, several recent high-profile incidents involving HPD officers<sup>i</sup> have emphasized the need for more accountability from, and oversight of, the Department. Yet, the Honolulu Police Commission's ability to adequately oversee the Department and take corrective action is severely hampered by the current charter's provisions. Local criminal justice scholars, as well as elected officials and even some Charter Commission members, have called for significant changes to be made.<sup>II</sup>

## **PROPOSED AMENDMENT #1**

- Issue: The Honolulu Police Commission needs to be made of up members who possess the right qualifications and experience, in order to properly understand and oversee the Department. Increasing the number of members, as well as term limits, would also be beneficial.
- Section affected: 6-1605.
- Proposed amendments:
  - o Increase the number of members from seven (7) to ten (10).
  - Limit each member to a four (4) year term, with a maximum of three (3) consecutive terms.
  - Require that at least three (3) members possess qualifications and experience such as: a master's degree related to criminal justice; a law degree and experience practicing in Hawaii as a deputy attorney general, deputy prosecutor, deputy public defender, or private criminal defense attorney; a law degree and experience litigating constitutional law issues in Hawaii; recognition as an expert in the field of criminal justice, policing, or security; work experience in a law enforcement capacity other than with HPD.
